## NOTICE

Applications are invited on the prescribed format for filling up **Two posts** of **Assistant Professor** on purely ad-hoc basis in Dr. B. R. Ambedkar Center for Biomedical Research (ACBR), University of Delhi, Delhi – 110 007 to teach M.Sc. students. <u>The applications should reach the ACBR office on or before **Thursday, the** <u>1</u><sup>st</sup> August, 2019</u>. The list of the shortlisted candidates will be displayed on 2<sup>nd</sup> August, 2019.

### The Interviews will be held on Monday, 5<sup>th</sup> August, 2019 from 09:30 a.m. onwards.

The prescribed format can be downloaded from the ACBR website i.e. <u>www.acbrdu.edu</u> and University of Delhi website i.e. <u>www.du.ac.in</u>. The prescribed qualifications, pay scale etc. are mentioned below:

#### **Essential Qualifications:**

- 1. Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University or an equivalent degree from an accredited foreign university.
- 2. The candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test at graded by the UGC.
- 3. The candidates who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedures for Award of Ph.D. Degree) Regulations 2009, shall be exempted from the requirement of the minimum eligibility condition of NET for recruitment and appointment of Assistant Professor or equivalent positions in University / Colleges / Institutes

Provided further, the award of degree to candidates registered for the M.Phil. / Ph.D. programme prior to 11<sup>th</sup> July 2009, shall be governed by the provisions of the then existing Ordinances / Bylaws/ Regulations of the Institutions awarding the degree and the Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions in Universities / Colleges / Institutes subject to the fulfillment of the following conditions:

- a. Ph.D. degree of the candidate awarded in regular mode only;
- b. Evaluation of the Ph.D. thesis by at least two external examiners;
- c. Open Ph.D. Viva voce of the candidate had been conducted;
- d. Candidate has published two research papers from / based on his / her Ph.D. work out of which at least one must be in the refereed journal;
- e. Candidate has made at least two presentations in conferences/ seminars, based on his / her Ph.D. work.
  - (a) to (e) as above are to be certified by the Vice-Chancellor/Pro-Vic Chancellor/Dean (Academic Affairs)/ Dean (University Instructions).

- 4. NET shall not be required for such Master's Degree Programme in disciplines for which NET or a similar test accredited by the UGC is not conducted.
- 5. The selected candidates will be required to teach **Human Physiology, Toxicology and Pharmacology** subjects. Please go through the syllabus given on the ACBR website for its contents.

#### **GENERAL NOTE:**

- i. Canvassing in any form will be treated as a disqualification.
- ii. Applications which do not meet the eligibility criteria given in this advertisement and / or are incomplete in any respect shall be summarily rejected.
- iii. Applicants must NOT furnish any particulars that are false, tampered or fabricated, or suppress any material / information while submitting the online application and uploading self-certified copies/testimonials.
- iv. The number/category of post advertised may vary, and the Center reserves the right not to fill up some or all posts advertised.
- v. In case of any dispute/ambiguity that may occur in the process of selection, the decision of the Center shall be final. Applicants are advised to satisfy themselves before applying that they possess the essential qualifications laid down in the advertisement.
- vi. No TA/DA shall be paid to candidates for attending interview.
