Applications are invited on the prescribed format (google form) for drawing up a Panel for appointment of <u>Guest Faculty for teaching M.Sc. Course in Biomedical Sciences at Dr. B. R. Ambedkar Center for Biomedical Research, University of Delhi and different colleges conducting B.Sc. course in Biomedical Sciences in University of Delhi for the year 2024-2025. The qualifications and other eligibility conditions for the post will be as per the UGC rules. All the applicants have to apply a fresh to include their name in this panel.</u>

*Essential Qualifications:

- 1. Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University or an equivalent degree from an accredited foreign university.
- 2. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Noncreamy Layer)/Differently-abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure. 3.5. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to19 September, 1991.
- 3. A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.

- 4. The candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test as graded by the UGC.
- 5. The candidate must have at least one degree in Biomedical Sciences (M.Sc./Ph.D.).
- 6. The candidates who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedures for Award of Ph.D. Degree) Regulations 2009, shall be exempted from the requirement of the minimum eligibility condition of NET for recruitment and appointment of Assistant Professor or equivalent positions in University / Colleges / Institutes.

Provided further, the award of degree to candidates registered for the M.Phil. / Ph.D. programme prior to 11th July 2009, shall be governed by the provisions of the then existing Ordinances / Bylaws/ Regulations of the Institutions awarding the degree and the Ph.D. candidates shall be exempted from the requirement of NET for recruitment and appointment of Assistant Professor or equivalent positions in Universities / Colleges / Institutes subject to the fulfillment of the following conditions:

- a. Ph.D. degree of the candidate awarded in regular mode only;
- b. Evaluation of the Ph.D. thesis by at least two external examiners;
- c. Open Ph.D. Viva voce of the candidate had been conducted;
- d. Candidate has published two research papers from / based on his / her Ph.D. work out of which at least one must be in the refereed journal;
- e. Candidate has made at least two presentations in conferences/ seminars, based on his / her Ph.D. work

The fulfilment of these conditions is to be certified by the competent authority of the University concerned.
